June 3, 2024
Proposed Minutes

Call to Order: Supervisor Mark Nunn called the meeting to order at 7:00 pm. Also present were Clerk Bob White, Treasurer Steve Ferguson, and Trustees Cheri Mioduch and Mary Pingot. Also, present were IT Dan Mioduch and Cemetery Sexton Deborah Mioduch. There were two guests.

The May 13, 2024, minutes were approved as presented.

Moved by White, seconded by Mioduch to receive the Treasurers Report for May. All ayes, motion carried.

Commission Reports

-Zoning Administrator/Ordinance Enforcement: 1 new permit and no new blight violations.

-Planning Commission: Next regular meeting is June 13th at 8 am.

-Cemetery: Sexton Deb Mioduch needs 300 feet of hose in order to clean the vinyl fence in front of the cemetery. The Clerk has a meeting with Milner Fence tomorrow about repairing/replacing the chain link fence portions damaged by falling tree limbs because of the January blizzard. Also discussed figuring out a way to delineate the “roadways” in the rear of the cemetery. Suggestion was made to use striping chalk rather than something more permanent.

-Assessor:

New Business:

-Supervisor discussed the East Tawas Fire Agreement, which is effect from October 1, 2024 September 30, 2025. The amount for the new agreement is \$23,221.47.

-Two representatives from Oscoda Area Schools discussed some of the details for the upcoming Iosco County Recycling initiative. One of the three disposal sites will be at Oscoda High School, one will be at Neiman’s Grocery Store, and one at the Plainfield Township transfer station. The initiative requires participants to use dual stream recycling, which means that paper and paper-like products must be separated from all other recyclables. A recommended funding plan, in accordance with Public Act 138 of 1990, involves a \$25/household/year (or about \$0.50/week).

-The clerk announced that the postal service will be raising first-class postage on July 14th to \$0.73, up from the current \$0.68.

Unfinished Business:

Paying of the Bills: Moved by Pingot, seconded by Mioduch, to pay the bills as presented. All ayes, motion carried.

2nd Public Comment Period: Individuals will be limited to three (3) minutes in which to address the Board.
